NOBLE PARK FSC LTD MEMBERSHIP TERMS AND CONDITIONS

1. MEMBERSHIP

- 1.1. Noble Park Football Social Club Ltd membership is charged annually, biannually or triennially. A person over the age of 18 years can download the membership form online at www.clubnoble.com.au or directly at reception at the club.
- 1.2. Members will be bound by these Terms and Conditions, which may vary. Noble Park FSC Ltd will attempt to notify members of changes but shall not be liable in failure to do so.
- 1.3. Members must notify the Noble Park FSC Ltd of changes to personal details or of a lost or stolen card. Noble Park FSC Ltd is not liable for delays in replacing membership cards or for unauthorised use.
- 1.4. Points cannot be credited or redeemed until mandatory fields are completed and membership fee is paid. Members can check point balances by asking a staff member or through the online login. Point disputes must be notified to the Noble Park FSC Ltd at enquiries@clubnoble.com.au. A written statement by the Noble Park FSC Ltd deciding any such dispute is final and binding.
- 1.5. Noble Park FSC Ltd may terminate a membership without notice for reason including, if the member
 - 1.5.1. fails to comply with membership Terms and Conditions
 - 1.5.2. abuses privileges,
 - 1.5.3. supplies misleading information or makes misrepresentations to the Noble Park FSC Ltd's staff
 - 1.5.4. or if the member does not renew their membership within 30 days of lapsing.
- 1.6. A member may terminate their membership at any time by written notice to the Noble Park FSC Ltd via post or email enquiries@clubnoble.com.au
- 1.7. Noble Park FSC Ltd membership cards remain the property of the Noble Park FSC Ltd.
- 1.8. Any tax liability, or duty arising from a members participation in the Noble Park FSC Ltd's program, is the member's responsibility.

2.0 EARNING POINTS AND REDEEMING POINTS

- 2.1. Points will be credited to a member's card for purchases on qualifying goods and services.
- 2.2. Noble Park FSC Ltd will determine the qualifying goods or services and number of points credited.
- 2.3. Membership cards must be presented to staff before the purchase is finalised. Failure to do so results in no points credited.

3.0. OTHER DEDUCTIONS OF POINTS

- 3.1. Noble Park FSC Ltd can decuct points if points credited were in error, a refund is given or purchase cancelled.
- 3.2. Any points not redeemed by the end of the financial year from initial joining date will automatically expire.

4.0. GENERAL

- 4.1. Noble Park FSC Ltd, without notice to members, can change the qualifying goods and services and the number of points awarded.
- **4.2.** Noble Park FSC Ltd reserves the right to suspend or terminate the rewards program without notice, and is not liable (without limitation) for any remaining members points balances at that time.
- 4.3. Noble Park FSC Ltd assumes no liability to a member for negligence, breach of contract or otherwise except,
- 4.3.1. any claim relating to points, and crediting the points to the member's rewards card.
- 4.4. Notice shall be deemed given by Noble Park FSC Ltd, if sent to the postal or e-mail address of the member appearing in the database.
- **4.5.** Playing a gaming machine or participating in a membership scheme that requires either expenditure on gaming machines, or agreement to receive gaming maching advertising, does not enable you to enter or participate in promotions linked to the Noble Park FSC Ltd's membership program.
- 4.6. These Terms and Conditions will be construed according to, and governed by the laws of Australia.

 - **5.1.4.** Date of birth and gender.
- **5.2.** Database information will be made available to Noble Park FSC Ltd's agents involved in administering the rewards program and used for marketing purposes.
- **5.3.** Each member consents and agrees to:
 - 5.3.1. Noble Park FSC Ltd and its agents, including Zen Global, accessing the database information;
 - **5.3.2.** disclosure of information contained in the member database to Noble Park FSC Ltd, Zen Global and its agents, for the purposes set out above.
